Terms and Conditions

1. By entering the "Face a Grilling at the 'G" (the "Competition"), you are agreeing to the following terms and conditions.
2. Information on how to enter forms part of the terms of entry.
3. Subject to clause 4, entry is open to all residents of Australia, 18 years of age and older.
4. Employees and their immediate families of Bunnings Group Limited, Cricket Australia and their associated agencies and companies are not eligible to enter.
5. Competition commences on **Wednesday 18 November 2015 at 09:00 AEDT** and closes on **Sunday 20 December 2015 at 23:59 AEDT** (the "Competition Period").
6. In order to enter, entrants must:

 - b) Click through to the competition entry page.
